All vehicles that use the N18 Limerick Tunnel Toll Road are photographed / video recorded. These photographs / images are retained for the purpose of enforcement and to address and resolve any disputes that may arise in relation to a vehicle or a Direct Route (Limerick) Ltd. Multi-trip card. We may disclose your personal data to our agents, contractors and service providers to the extent reasonably required for the purposes described above. If at any time we decide to use your personal data in a manner significantly different from that stated in this data protection notice, or otherwise disclosed to you at the time it was collected, we will notify you, and you will have the choice as to whether or not we use your information in the new manner. You have the right, subject to certain exemptions, to obtain a copy of any personal data we hold about you and to correct any inaccuracies in such data.
